<p><b>4. FEBRUARY FINANCIAL ISSUES:</b> CFO Babcock reported the hospital received \$225,000 payment for Medicare FY09 which was re-distributed to pay for basic necessary expenses. She reported payment to Cal-Mortgage was unable to be paid for the months Nov/Dec/Jan/Feb to bring balance current per action by BOD. She reported non-payment will be discussed with Cal-Mortgage during meeting 2/8/10 to discuss fall-out if any. Babcock reported she notified JP Marion, Cal-Mortgage.</p> <p>Babcock dispersed and reviewed financial data and current status including recommended actions to continue superior level of patient care that is primary mission of Mayers. This information and data will also be distributed and discussed with Cal-Mortgage staff during meeting February 8<sup>th</sup>. No action at this time.</p> <p>Hamlin recommended new Cal-Mortgage payment plan and/or modification of schedule during the February board meeting—possibly new action necessary since unable to execute first plan. Kerns stated approach would be clarified at meeting with Cal-Mortgage and presented at February BOD meeting.</p>
