Requests Audience to Speak	Don Smith & Marlene VanStaaveren: Attended to join conversation regarding implementing dialysis; willing to help with any steps in the process; thanked the committee for their research; will attend the next meeting	
Minutes	July 10, 2017 Strategic Planning Committee meeting minutes. <i>Approved All</i> (Lakey, Harris) (no objections)	Approved
Facilities	New windows being installed (rooms and bathrooms) will be completed end of next week; new door skins in SNF; new fire doors going in also; looking into rural exemption for water tanks, if that doesn't work will look into generator for existing tanks; updated bid on parking lot in Burney, reduced \$14k, will do RFP to see if price can be lowered even more, will bring back to board; developing in-house laundry program in Burney, building needs to roof, upgraded electrical to handle washers and dryers, new flooring;	Report
Proposed Services (Dialysis) Follow-Up	Louis provided handout of Title 22 requirements; good news it is possible, bad news it will be difficult; there are minimum requirements for patient numbers (3-4); spoke with Dr. Goodwin at Pit River Health, currently has 5 patients transported to Redding for hemodialysis 3 times per week, MVHC has less, can also try Canby; not a direct supervisional position, dcotor would be credentialed but not required to be on site; need certified RN with 6 month background in kidney failure, will be challenge to find that, definitely need someone with experience; can acquire P&Ps from other facilities; not concerned with space requirements; still need referral info from MVHC; looking forward, what happens with the volumes reduce? Dialysis is revenue/expenses situation, not cost-based reimbursement like most of our other services, need to be sure it can be financially stable; need to talk with insurances to see if we can get the cost to patients close to what they would pay in Redding; next step is confirm patient referrals, reimbursement and payer mix, will have more info by next SP meeting; licensure process is about 10 month process; will talk with CDPH about an estimated timeframe on program implementation; try to set an appointment with another facility to discuss options, possibly Reno because they wouldn't be concerned with competition; discuss possibly partnering with clinic in Redding to come up and use our facility and equipment, or mobile dialysis;	Discussion
