3 STRATEGIC PLANNING FY2025-2029 UPDATE:

The Strategic Plan still seems valid and reachable for this fiscal year – including the initiative, services, etc. August 11th, Surveryors will be here to service the MRI. It was agreed to continue with the approved Strategic Plan.

4 CONSTRUCTION

4.1 Master Plan – Phase 1 Update

Travis sent out proposal requests- about 10 from the USDA list. We will need private financing for the interim construction portion, and then it will roll over to USDA after the fact. USDA will use the feasibility study to approve or not approve the loan. Overall, it is back to the drawing board when it comes to our Master Planbased on what will generate income and modify the plan strategically.

The study will be completed tomorrow afternoon- based on findings, perhaps phases will be introduced to achieve the necessary builds. All current constructions projects will be brought to the full board to discuss the importance or direction that Ryan needs to take, based on the needs of the community.

4.2 Deferred Maintenance Projects

Nurse Call Project for both sites has begun. Grease trap fix in Burney is required with additional plumbing. A list of all deferred maintenance projects can be presented in the August 2025 Board Meeting.

4.3 Other Construction Projects

Solar Project is scheduled to end October 25th as the new deadline.

5 OTHER INFORMATION/ANNOUNCEMENTS

The TCCN permits have been submitted to the County. The TCCN upstairs occupancy is dependent on the childcare compliance phase being completed so it's up in the air if the occupancy can be changed to office space instead of childcare. A locum provider has been established for the RHC, starting August 11th. There are 2 perm providers posted on our website. Ryan and Theresa rounded on the depts, providing insights and answering questions regarding the Big Bill.
