Approving the Purchase of Real Property from the Fort Crook Masonic Building

WHEREAS, the Board of Directors ("Board") of Mayers Memorial Healthcare District (MMHD) has the need to acquire real property to support its mission to provide quality healthcare services to the community; and

WHEREAS, MMHD has identified a parcel of real property owned by the Fort Crook Masons (the "Seller") as suitable and beneficial for its current and future operational needs; and

WHEREAS, MMHD has conducted all necessary due diligence, including but not limited to legal review, property appraisal, and environmental assessment, and has negotiated a purchase agreement with the Sellers for the acquisition of said property; and

- 4. Effective Date: this Resolution shall take effect immediately upon its adoption.
